STATEMENT OF UNDERSTANDING AND AGREEMENT:

I understand that I am responsible for preparing my placement site for the Farley Boat, that my placement site must be prepared prior to delivery of my Farley Boat, and that my placement site must support the weight of my Farley Boat, approximately 1600 lbs. I further understand the delivery forklift must have a clear path to my placement site or to my loading trailer. I further understand that when I am ready to accept delivery of my Farley Boat, I will call the City of Port Aransas Public Works at 361-749-5125 to schedule a delivery time. I further understand there may be a delay in receiving my Farley Boat as I must coordinate my delivery with the City of Port Aransas' work load.

I understand my order is not binding on Port Aransas Garden Club, Inc. until I receive confirmation my order is received and accepted. If for any reason my order cannot be filled, Port Aransas Garden Club, Inc. will return my purchase price. Other than the return of my purchase price, Port Aransas Garden Club, Inc. shall not be responsible for any costs or damages arising from or related to its inability to fill my order.

I understand the City of Port Aransas will deliver my Farley Boat. Port Aransas Garden Club, Inc. shall not be responsible for any damage arising from or related to the delivery of my Farley Boat.
